Under the new label, only certified applicators who have a pesticide license and have completed this training will be able to load, mix, and/or apply paraquat. No longer will persons under the direct supervision of a certified applicator be able to use the product. The training will have to be completed once every 3 years.

Pesticide Training & Testing Category 3, 5, and 6 Training and Testing To prepare workers to take the certification exam, we provide six hours of instruction, and at the completion of the training, the Department of Agriculture administers the exam. With the instruction fresh in their minds, 90 percent of the workers pass the exam the first time.

Paraquat is an IMPORTANT part of nearly every single sound management program UGA weed science recommends in agronomic crops. Critical points to remember include: a) paraquat can only be applied by a certified pesticide applicator and b) an EPA-approved paraquat training is required every 3 years.

In cooperation with the Georgia Department of Technical and Adult Education, the Georgia Department of Agriculture offers the Pesticide Applicator 's Exam as a computer based program. This computer based exam is available at many technical colleges in Georgia. Pesticide applicators schedule an exam date and time at their convenience.
